## Countdown to Liftoff



## Mt. Bachelor, Oregon, February 23 to March 2, 2013

Oregon is not a state that most people ever ski. There are a few ski resorts in Oregon, but Mt. Bachelor is the most well-known, which is a massive volcanic mountain. It has a unique image of a lone Mountain of 9000' elevation, hence the name Bachelor! The "Cone" is a 7000' cinder cone on the northern flank, 715' vertical, and has skiing 360° from the top. Because the ski area has 55% advanced/expert runs, it attracts more advanced skiers. Several of the clear-sky weather days, the chair lift opened to the top, and you could see **Mike and Charlene Fleming** skiing on super snow! **Nelson and Marti Turner** and most of the skiers that made it to the summit gave a consensus that it was a spectacular view from the top! The mountains surrounding Mt. Bachelor are the Three Sisters volcanic peaks each exceeding 10,000' elevation, were named Faith, Hope and Charity by early settlers, and now commonly known as North Sister, Middle Sister, and South Sister. Did you know there is often skiing through the summer at Mt. Bachelor and now the end of April the mountain is still open!



We have many reasons that we all belong to Space City Ski Club. We want to ski (or travel), we don't have to research where to ski and where to stay, yet we sign up for a unique resort destination, check another state or location off our list, and meet new ski and travel friends. SCSC Members that signed up for the Mt. Bachelor trip were looking for a unique ski opportunity, **Kate Barry** wanted a get-away to a new location as a non-skier, she and **Angela Stagg** signed up to meet new ski friends, **Steve Ying** wanted to return because he skied at Mt. Bachelor several years ago and remembers how outstanding the Mountain Ambassadors were (guides on the mountain), **Beverly Roberts** signed up along with many of the "Big Dogs" to follow **Keith Kirkman** to a resort for great skiing. TC **Ellen Eastham** and ATC **Tom Danowski** had both skied many years with SCSC, never in Oregon, and never together, even though they have dated 7 years! So ski trips are a first for many reasons that result in new friendships. **Dennis Hughes**, prior SCSC TC for Mt. Bachelor in 2010, and his wife who is current President, **Melinda Hughes**, decided to return to superb accommodations at Sunriver Resort. The recently opened Aquatic & Recreation Center included indoor and outdoor pools, fitness center and hot tub. **Bruce Fleming** had a great workout in the weight room and visiting the new \$20MM facilities!

February is the low season for Sunriver Resort because summer months are for fishing, golf, and travel time for families that book the resort solid. With fewer guests, we had prompt shuttle service anywhere we needed to go at the huge resort and superior hospitality. Also staying at Sunriver were participants with the California LA Ski Council and Connecticut Snow Snakes. SCSC had various mixers with them at Sunriver, such as the Welcome Party Saturday evening soon after arrival, when we were introduced to Ann Cook, who is the rep from Mt. Bachelor, and her fun side-kick, Carol Mergenthaler. We joined the other ski clubs Monday evening for Salsa Dance Lessons and a Mexican Dinner at the beautiful rustic historic Great Hall at Sunriver. Built in 1944, it is the only remaining structure of the original Camp Abbot Army Base. The food was not Tex-Mex, but there was a nice table set up with a sombrero and colorful decorations on the buffet. **Dennis and Melinda Hughes, Jim Hodges and Mariana Wang** showed everyone how to dance as they have been taking Salsa Dance lessons in Texas. 



**1.0 DUES. (Amended 8-28-05)**

A. Members may pay dues in 1-year or 3-year increments. Dues shall be as follows: (Amended )

1-year \$40 single	\$70 Family
3-year \$99 single	\$189 Family

Two individuals applying for a family membership must use the same mailing address and will receive one (1) monthly copy of the Sitzmarke, when published.

B. Members who renew their current membership within the first month of the membership renewal year will receive a \$5 discount per membership. Dues with this discount included shall be as follows:

1-year \$35 single	\$65 Family

C. Dues are nonrefundable may not be pro-rated and may not be converted to family membership during the first membership year. In subsequent years for the 3 year memberships, conversion from single to family memberships and vice versa will be allowed. If such a request is made, the Executive Committee shall determine on a case-by case basis any additional dues money required (or refunded) as well as any remaining time on a revised single or dual membership.

**5.0 TRIP PENALTIES.****5.1 FINAL PAYMENT DATE**

A. If a trip participant withdraws from a trip after the published final payment date, the trip participant will lose the entire payment upon withdrawal. If the participant can be replaced from the waiting list, the participant will be refunded the entire payment less any costs incurred by the Club in addition to cancellation fees as specified in 5.2. If the trip participant cannot be replaced from the waiting list, the participant will be refunded the amount which the Trip Coordinator is able to recover by cancellation of lodging, transportation, and/or other commitments less any costs incurred by the Club and cancellation fees as specified in 5.2.

B. If a trip participant fails to make final payment by the published final payment date the Trip Coordinator may replace the participant after making a diligent effort to contact the participant, who will be subject to cancellation fees as specified in 5.2.

**5.2 CANCELLATION FEES.**

A participant may forfeit his full deposit if he fails to notify the Club in writing of his intent to withdraw on or before the published final payment dates. A minimum charge of \$30.00 or 20% of the published trip cost, whichever is less, said amount not to be less than \$10.00 will be assessed for each trip cancellation.

5.3 Deposit and cancellation charges for non-domestic trips shall be determined by the Executive Committee and included in the trip release form as well as in all trip publicity; in no case shall these requirements be less than those provided in Sections 5.2 and 5.3 of these Standing Rules. (Amended to remove transfer 9-9-2003, Effective 5-1-2004)

**5.4 NO SNOW.**

If the Club encounters a cancellation situation prior to the departure of a trip, the trip participant is entitled to recover the entire cost of the trip less charges incurred by the Club as a penalty for cancellation of lodging, transportation, operating expenses and/or other commitments made on behalf of a trip participant. Refunds to any trip will be made upon receipt by the Club of the total refund due the Club by the resort, airline and/or other entity or as approved by the Executive Committee.

**7.0 RESTRICTIONS.**

7.1 Allowing non-trip participants to occupy any room as a non-registered guest is strictly prohibited, and in violation of Club policy.

7.2 The illegal use of controlled substances during Club trips, or any other official Club function, is in violation of Club policy, and is strictly prohibited.

7.3 No substitutions of trip participants shall be allowed without the knowledge and approval of the Trip Coordinator, and new additions to the trip shall come from that trip's Waiting List. The Trip Coordinator shall make all substitutions.

7.4 It is the policy of the Club not to allow the active solicitation of the general membership at a Club function or in the Club publication for any other than Club sponsored trips or activities without the consent of the Executive Committee.

7.5 No person may participate in a Club sponsored trip, or participant paid activity, without first completing a written and signed Release of Liability for that trip or activity, on a form approved by the Board of Directors.

7.6 No person may sign up on a wait list for a Club sponsored ski trip without being a member in good standing. A trip must be full before a wait list can be started. A deposit is required in order to sign up on a trip wait list.

7.7 A Club Officer, Director, Director(s) of Trips, Director of Programs, Assistant Treasurer or Audit Committee Chair shall not accept a gratuity in excess of \$25.00 from a vendor without notice to the Executive Committee.

**8.0 MISCELLANEOUS.****8.1 SKI TRIP SIGN UP.**

A. Members shall be allowed to sign up for club ski trips each year by 1) following the directions for Mail-In Sign Up, as published in the August issue of the Sitzmarke newsletter, or 2) beginning with the opening of the August General Meeting, by contacting the Trip Coordinator and paying the appropriate deposit or amount due for the trip. No other methods of sign up will be accepted, except as authorized by the Executive Committee and published in advance in the Sitzmarke.

B. Each member may sign up for him/herself and one other member on any ski trip or ski trip waiting list.

8.2 WEATHER. If a trip should be "weathered-in," the additional lodging expense will be left up to the individual, although the Trip Coordinator will assist in making accommodation arrangements and collection for same shall be left up to the lodge.

8.3 NON-SKI TRIPS/ACTIVITIES. Reservations for participation in such activities may require full payment, instead of a deposit fee.

8.4 DIRECTORY. The membership directory is available online at [www.spacecity.org](http://www.spacecity.org).

8.5 A member who does not follow/adhere to accepted business practices in financial dealings by, for, or with the Club is in violation of Club policy, is subject to disciplinary action, and may be held financially responsible for any resulting liability incurred by the Club.

8.6 A member who fails to abide by the laws of the state in which an activity or trip is being held and/or fails to meet policies and rules of our contractual vendors (airlines, bus lines, lodging and/or properties, etc.) while participating in a Club activity or trip, which results in placing himself, another member, or the Club into a position of liability, is in violation of Club policy and is subject to disciplinary action as stated in the SCSC By-Laws Article 2.4.

**8.7 TRIP PACKAGES**

A. It is the policy of the Club to sell complete trip packages (air, lodging, and ground transportation) at the full budgeted price unless otherwise authorized by the Executive Committee.

B. "Shadow participants" shall be defined as members making their own travel and lodging arrangements, but wishing to participate in club or Texas Ski Council activities on a trip. This type of participation will be allowed on each ski trip as authorized by the Executive Committee. Shadow participants shall pay the appropriate fee for the trip's activities plus a \$10.00 shadow participant fee, the sum of which shall be set forth on the approved trip budget.

**APPLICATION FOR MEMBERSHIP AND RELEASE OF LIABILITY**
