Final arrangements have been made for another Ruidoso trip, March 14-17. Reservations are confirmed for charter bus travel and hotel accommodations for thirty-six people.

Departure time will be 6:00 PM, Thursday March 14, from the parking lot adjacent to LOOK'S SIR LOIN HOUSE, 6112 Westheimer. Bring your supper --- no planned meal stop! There may be a breakfast stop. If not, rolls or doughnuts will be provided. Arrival at the HIGH COUNTRY LODGE in Ruidoso will be approximately 9:00 AM, Friday March 15. Rented skis will be waiting at the Lodge as will autos to get to the ski slopes as soon as possible. Four persons will share an apartment complete with 4 separate beds and Kitchen Facilities.

Return to Houston will be Sunday, March 17 at 2 PM with expected arrival time 6:30 AM, Monday March 18.

Trip Cost to each member, including transportation and lodging, will be \$59.00. Ski rental will be \$12.50 and Insurance \$3.33. (A blank subscription is enclosed).

There will be a meeting with the Trip Chairman during the next regular Monthly Meeting, March 11, to discuss final arrangements.

This should be a FUN trip with EXCELLENT skiing if snow conditions continue as they have all winter. But-----HURRY----- time is short, just over 2 weeks!
